Overview and Introduction

This Research Guide will assist in locating legal resources regarding Medicare, Medicaid and Medi-Cal. It is not intended as a substitute for legal advice. The laws and regulations change frequently, so check that any resources you are using are up to date. Please consult with an attorney if you need legal advice.

Created in the mid-1960s as part of the Social Security system, Medicare and Medicaid are often confused with each other, but there are crucial differences. Medicare is a federally funded health plan providing medical benefits to people 65 and older, as well as individuals who are blind or disabled. Medicaid is a federal program operated at the state level. To qualify for Medicaid (known as Medi-Cal in California), a person must meet the income and resource guidelines in his/her state.

Treatises

Treatises provide commentary and explanations regarding Medicare and Medicaid law. They are not the actual law, but it is a good idea to consult them first to obtain an overview of the law, as well as citations to relevant cases and statutes. Please note that not all treatises are available at all of the Law Library branches.

Federal and General Treatises:

This Nolo Press self-help book provides a plain-English explanation of Medicare and Medicaid law. It is available at all branches of the SDCPLL.

Chapter 4 on Medicare and Medigap, in addition to Chapter 5 on Medicaid, provide a good overview.

Has six volumes of detailed information regarding Medicare and Medicaid, particularly provider reimbursement and billing instructions

This is a two-volume treatise that discusses how to file Medicare and Medicaid claims.
